Dear Neighbor,

As your representative in Congress, I have, from day one, prioritized bringing your voices with me to Washington and reconnecting our communities to Congress. This year, I focused on lowering costs, making our communities safer, protecting your freedoms, and improving and expanding our infrastructure.

I know Northeast Ohioans are feeling the impact of higher prices of everything, especially housing. Corporations play a huge role in rising housing costs, buying up large amounts of homes and forcing people out of neighborhoods and communities they've been a part of their whole lives. That's why I introduced the *Stop Predatory Investing Act* and the *Keep Affordable Housing in Forgotten Communities Act*, to lower the cost of housing in our communities.

Improving public safety is another important priority of mine because every person deserves to feel safe and secure in their communities. I'm committed to making Ohio's 13th Congressional District a safer place to live, work, and grow up. My common sense, bipartisan legislation – the *Law Enforcement Scenario-Based Training for Safety and De-Escalation Act* – would create a real-life, scenario-based training curriculum for law enforcement, so they are better prepared to serve you. A variety of local and federal stakeholders support this legislation including the national Fraternal Order of Police, the Akron NAACP, and the Federal Law Enforcement Officers Association.

We must also ensure that we fight for those who have protected us. I introduced the *Extension of Department of Veterans Affairs Expiring Authorities Act*, which was signed into law in September. This bill reauthorizes several key veteran programs and services. I am also a strong supporter of the *PACT Act* – the most comprehensive legislation to date to treat toxic exposure as a cost of war and ensure that all toxic-exposed veterans can access the care and benefits they've earned. I even invited Tim Hauser, a local veteran and PACT Act advocate, to attend this year's State of the Union as my guest.

I will not stop fighting to defend your freedoms. This year, I introduced the *Reaffirming Emergency Abortion Care for All Resolution*, which would protect access to emergency abortion care in every state. All women, no matter where they live, should be able to receive the emergency care they need, including abortion. I also cosponsored the *Access to Family Building Act*, which would guarantee all Americans have the statutory right to access assisted reproductive technology, including IVF.

Finally, I am proud to have delivered \$157,265,405 in federal funds to Ohio's 13th Congressional District. These are your tax dollars coming back to our communities to support infrastructure, job growth, first responders, public education, and more. I'm very proud to report I helped deliver \$51 million for the Akron Sustainable Polymers Tech Hub to create goodpaying jobs and grow our local economy. This investment will ensure Northeast Ohio remains a global leader and trailblazer in polymer science and polymer engineering, reaffirming our district's legacy as the Rubber Capital of the World.

I'm confident we will continue to deliver results and expand opportunities for everyone. I'll keep putting people before politics and working across the aisle to secure meaningful results for our district and country. I am proud to work for you. Lowering Costs

From day one, I have been working to lower everyday costs by:

- Advocating for the Affordable Connectivity Program to be fully funded so Ohioans can connect to affordable high-speed internet;
- Introducing the *Stop Predatory Investing Act* to lower home prices and stop greedy corporations from buying up homes;
- Cosponsoring the *Keep Affordable Housing in Forgotten Communities Act* to lower housing costs and protect longtime residents from being displaced from their neighborhoods.

This year, I introduced the *Law Enforcement Scenario-Based Training for Safety and De-Escalation Act*. I'm working to secure federal funds to fix our roads and bridges as well as invest in our airports. This year, I delivered \$10,129,784 in community project funding for infrastructure projects across Ohio's 13th Congressional District. I also cosponsored the *Stronger Communities through Better Transit Act* to support local transit authorities through federal grants, because I know that reliable transit systems are vital to a thriving community for all people.


