# 2025 Congressional Art Competition HOSTED BY CONGRESSWOMAN EMILIA SYKES

Each spring, a nationwide high school arts competition is sponsored by the Members of the U.S. House of Representatives. The Congressional Art Competition is an opportunity to recognize and encourage the artistic talent in the nation, including Ohio's 13th Congressional District. The winning artwork of our district's competition will be displayed for one year in the U.S. Capitol. The exhibit in Washington will include the winning artwork from all participating districts from around the country.

## **1. GENERAL GUIDELINES**

All high school students in grades 9 through 12 who live in Ohio's 13th Congressional District are eligible to submit one piece of artwork. Artwork entered in the contest may be up to 28 inches by 28 inches, may be up to 4 inches in depth, and not weigh more than 15 pounds. If your artwork is selected as the winning piece, it must still measure no larger than the above maximum dimensions while framed. The following mediums are accepted:

- Paintings including oil, acrylics, and watercolor
- Drawings including pastels, colored pencil, pencil, charcoal, ink, and markers (It is recommended that charcoal and pastel drawings be fixed.)
- Collages must be two dimensional
- Prints including lithographs, silkscreen, and block prints
- Mixed Media use of more than two mediums such as pencil, ink, watercolor, etc.
- Computer-generated art
- Photography

All entries must be original in concept, design and execution and may not violate any U.S. copyright laws. Any entry that has been copied from an existing photo or image (including a painting, graphic, or advertisement) that was created by someone other than the student is a violation of the competition rules and will not be accepted. Work entered must be in the original medium (that is, not a scanned reproduction of a painting or drawing). Artwork must adhere to the policy of the House Office Building Commission. Pieces may not depict a "contemporary political controversy" or be "sensationalistic or gruesome." According to the official

is the deadline for interested students to submit their artwork.

guidelines, "While it is not the intent to censor any artwork, we do wish to avoid artwork that is potentially inappropriate for display in this highly traveled area leading to the Capitol."

# **ART COMPETITION GUIDELINES**

### **2. TIMELINE**

The following is an approximate timeline for the 2025 Congressional Art Competition:

- February: Congresswoman Emilia Sykes' Office begins accepting student submissions.
- March 24: Deadline for students to submit artwork for consideration to one of the approved drop off locations.
- Late April: The overall winner from Ohio's 13th Congressional District will be announced.
- June: The Congressional Institute will hold a reception in Washington D.C. for the winners across the country.

### **3. HOW TO PARTICIPATE**

Applicants must submit their original piece of artwork. Scanned images of artwork will not be accepted. All artwork should be matted or framed. Along with their artwork, students must include the 2025 Student Submission Form attached to this packet. Use the checklist to the right to ensure your submission is complete and meets all of the requirements. Artwork can be dropped off at the following locations:

### **4. NEXT STEPS**

Once the March 24 deadline to submit artwork passes, a judging panel of art professionals will evaluate each submission. The overall winner will be announced in
