That's why I voted against Republicans' One Big Ugly Bill, which will kick millions of Americans off their health care. I also co-sponsored the **Health Care Affordability Act**, which would make the Affordable Care Act tax credits permanent, and reintroduced the **Lower Your Taxes Act**, which would raise taxes on corporations and expand the Earned Income Tax Credit and the Child Tax Credit. Corporations also play a huge role in rising costs, which is why I was proud to introduce the **Junk Fee Prevention Act** and the **Airline Passenger Compensation Act**. Both bills would help protect consumers from greedy corporations and keep more of your hard-earned money in your pockets.


Ending government corruption is another important priority of mine because when public officials use their power for personal gain, democracy itself is undermined. I joined a group of legislators to introduce the **End Corruption Now** legislative agenda. As part of the agenda, I introduced the **Closing Bribery Loopholes Act**. This legislation is especially timely, with Ohio having been ranked as the worst state for public corruption in the country.

I'm committed to making Ohio's 13th Congressional District a safer place to live, work, and grow up. My common sense, bipartisan legislation – the **Law Enforcement Scenario-Based Training for Safety and De-Escalation Act** – would create a real-life, scenario-based training curriculum for law enforcement, to better prepare officers for the situations they face in the field. This year, I also reintroduced the **Safer Homes and Families Legislative Agenda** to protect survivors of domestic violence and strengthen support systems nationwide.

Finally, I am proud to have delivered more than **\$243 million** in federal funds to Ohio's 13th Congressional District. These are your tax dollars coming back to our communities to support infrastructure, job growth, first responders, public education, and more. I also helped return nearly **\$8 million** to constituents that was owed from federal agencies and my team helped nearly 1,200 people in our community cut through red tape and ensure that our government works for you.

I'm confident we will continue to deliver results and expand opportunities for everyone. I'll keep putting people before politics and working across the aisle to secure meaningful results for our district and country. I am proud to work for you. Keeping More Money in Your Pockets

This year, I introduced several bills to keep more money in your pocket. The first bill I reintroduced this year was the ***Lower Your Taxes Act***, which would raise taxes on corporations and expand the Earned Income Tax Credit and the Child Tax Credit. The ***Junk Fee Prevention Act*** cracks down on deceptive and hidden fees that drive up consumer costs and requires transparency so families know the true price of services they rely on. The ***Airline Passenger Compensation Act*** would require U.S. airlines to provide cash compensation and rebooking assistance to passengers affected by airline-caused delays and cancellations.



Fighting for Affordable Health Care

Our country is in an affordable health care crisis, caused by the Republicans' One Big Ugly Bill. Due to slashing Medicaid and refusing to extend the Affordable Care Act (ACA) subsidies, millions of Americans face the reality of rising health care costs. That's why I voted against the One Big Ugly Bill and co-sponsored the ***Health Care Affordability Act***, which would make the ACA tax credits permanent. I also introduced the bipartisan ***Food Farmacy Act***, to expand access to nutritious foods and nutritional guidance. Food farmacies can be effective in improving patient understanding of nutrition, removing barriers to healthy eating, and utilizing food as medicine to help manage illness and disease.



Ending Government Corruption

I joined a group of legislators to introduce the ***End Corruption Now*** legislative agenda. As part of the agenda, I introduced the ***Closing Bribery Loopholes Act***. My bill would expand the definition of "official acts" to include anything done by someone in their capacity as a public official, such as hosting events on publicly owned property. Under this expanded definition, performing these official acts for private gain would be defined as bribery. When public officials use their power for personal gain, democracy itself is undermined. This bill and the broader ***End Corruption Now*** agenda is about restoring public trust and ensuring that no one is above the law.

Empowering Working People

I'm working to grow the middle class by creating an economy that works for everyone, especially working people. This year, I introduced the bipartisan ***No Tax on Overtime for All Workers Act*** to expand the no tax on overtime provision for workers whose eligibility was excluded from the provisions included in the One Big Ugly Bill. I also supported the ***Protect America's Workforce Act***, which would restore collective bargaining rights for over one million federal employees. I was proud to sign the discharge petition to bring this legislation to the House floor, where it passed with bipartisan support.



Keeping Our Communities Safe

Every person deserves to live free from fear and violence. That's why I reintroduced the ***Safer Homes and Families Legislative Agenda***, a comprehensive legislative slate consisting of three bills to protect survivors of domestic violence and strengthen support systems nationwide. I also reintroduced the ***Law Enforcement Scenario-Based Training for Safety and De-Escalation Act***. This bipartisan bill would create a real-life, scenario-based training curriculum for law enforcement personnel based on the wide range of issues they encounter while serving our communities.



Strengthening Our Infrastructure

As a member of the House Transportation and Infrastructure Committee, I'm committed to strengthening our infrastructure. I'm working to secure federal funds to fix our roads and bridges as well as invest in our airports. This year, I reintroduced the ***RAIL Act***, which would improve rail safety and keep our communities safe. I also introduced the bipartisan ***Ohio River Restoration Program Act***, which would dedicate \$350 million to protect and restore the river. The bill would fund projects like habitat restoration, pollution prevention, and workforce training, while ensuring that residents have a voice in decisions that affect their water and communities.

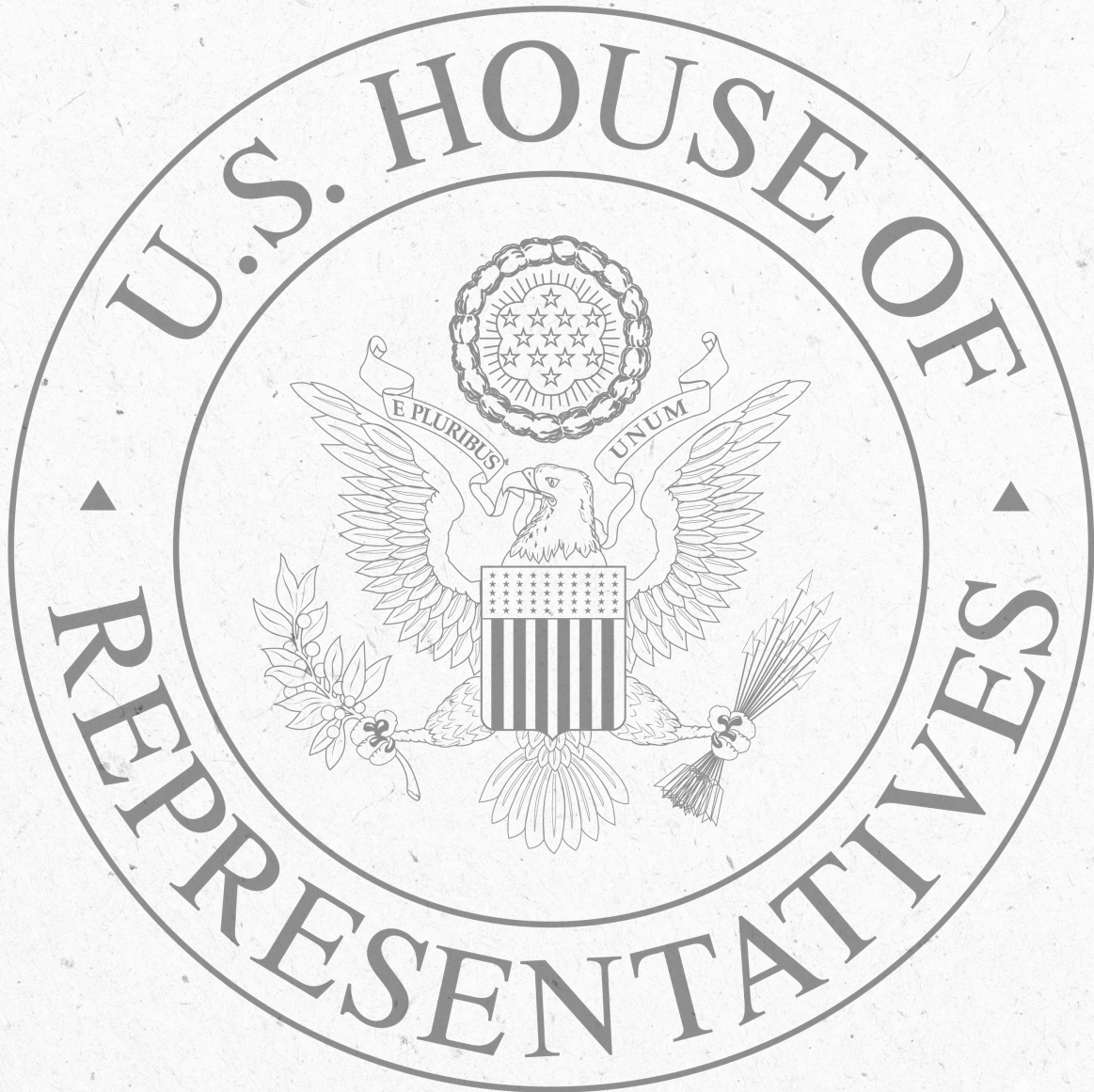
