

Congressional Art COMPETITION 2024




Each spring, a nationwide high school arts competition is sponsored by the Members of the U.S. House of Representatives. The Congressional Art Competition is an opportunity to recognize and encourage the artistic talent in the nation, including Ohio's 13th Congressional District. The winning artwork of our district's competition will be displayed for one year in the U.S. Capitol. The exhibit in Washington will include the winning artwork from all participating districts from around the country.

1. General Guidelines

All high school students in grades 9 through 12 who live in Ohio's 13th Congressional District are eligible to submit **one** piece of artwork. Artwork entered in the contest may be up to 28 inches by 28 inches, may be up to 4 inches in depth, and not weigh more than 15 pounds. If your artwork is selected as the winning piece, it must still measure no larger than the above maximum dimensions while framed. The following mediums are accepted:

- Paintings - including oil, acrylics, and watercolor
- Drawings - including pastels, colored pencil, pencil, charcoal, ink, and markers (It is recommended that charcoal and pastel drawings be fixed.)
- Collages - must be two dimensional
- Prints - including lithographs, silkscreen, and block prints
- Mixed Media - use of more than two mediums such as pencil, ink, watercolor, etc.
- Computer-generated art
- Photography

All entries must be original in concept, design and execution and may not violate any U.S. copyright laws. Any entry that has been copied from an existing photo or image (including a painting, graphic, or advertisement) that was created by someone other than the student is a violation of the competition rules and will not be accepted. Work entered must be in the original medium (that is, not a scanned reproduction of a painting or drawing). Artwork must adhere to the policy of the House Office Building Commission. Pieces may not depict a "contemporary political controversy" or be "sensationalistic or gruesome." According to the official guidelines, "While it is not the intent to censor any artwork, we do wish to avoid artwork that is potentially inappropriate for display in this highly traveled area leading to the Capitol."

2. Timeline

The following is an approximate timeline for the 2024 Congressional Art Competition:

- February 9: Congresswoman Emilia Sykes' Office begins accepting student submissions.
- April 5: Deadline for students to submit artwork for consideration to Congresswoman Sykes' District Office.
- Late April: The overall winner from Ohio's 13th Congressional District will be announced.
- June 27: The Congressional Institute will hold a reception in Washington D.C. for the winners across the country.

3. How to Apply

Applicants must submit their original piece of artwork. Scanned images of artwork will not be accepted. Along with their artwork, students must include the 2024 Student Submission Forms. These forms are attached to this packet. A completed form requires a signature from the applicant, their parent/guardian, and art teacher. Use the checklist to the right to ensure your submission is complete and meets all of the requirements.

3. Next Steps

Once the April 5 deadline to submit artwork passes, a judging panel of art professionals will evaluate each submission. The overall winner will be announced in late April. More information about that announcement will be provided to those who participate in the competition. The overall winner for Ohio's 13th Congressional District will have the opportunity to travel to Washington D.C. to participate in a reception with the other district winners from across the country.

Checklist



- Confirm you live in Ohio's 13th Congressional District by using the "Find Your Representative" tool on house.gov.
- The artwork is one of the accepted mediums for the competition.
- The artwork is no larger than 28 inches by 28 inches, may be up to 4 inches in depth, and not weigh more than 15 pounds.
- Artwork adheres to the policy of the House Office Building Commission.
- The Student Submission Form has the signature of the applicant, their parent/guardian, and art teacher.
- The Student Submission Form is attached to the back of the artwork and arrows are attached to indicate the orientation of the art.
- Artwork is submitted in its original form to Congresswoman Emilia Sykes' District Office by April 5, 2024.
