
PROJECT 2025 By the Numbers

Project 2025 imposes "time limits or lifetime caps" on Medicaid benefits, which could strip 43,000 away coverage from 43,000 low-income individuals in Ohio's 13th Congressional District after they have been on Medicaid for a set amount of time, regardless of their health or economic needs.



Under Project 2025, the typical family of four in Ohio would see a tax increase of \$2,814 per year. Meanwhile, 45,000 households nationwide with incomes over \$10 million would receive a \$1.5 million tax cut.

Project 2025 would push seniors into 1,106,168 corporate health insurance plans rather than traditional Medicare by making Medicare Advantage the default option. As Medicare shrinks, it could open the door to benefit cuts and privatization schemes that threaten the health and pocket books of 1,106,168 people enrolled in traditional Medicare in Ohio, including 80,000 in Ohio's 13th Congressional District.

Project 2025

The plan would eliminate the Head Start 1,900 program, which provides access to no-cost child care and other services for 1,900 low-income children in Ohio's 13th Congressional District. Eliminating Head Start would raise costs for families in Ohio that are already struggling to make ends meet, exacerbate the shortage of child care slots, and undermine economic growth.

Project 2025 replaces income-driven 299,600 repayment (IDR) plans with a one-size-fitsall program that would increase payments for all borrowers enrolled in existing IDR plans, including Democrat's Saving on a Valuable Education (SAVE) Plan. Under Project 2025, 299,600 borrowers in Ohio enrolled in SAVE could be forced to pay \$2,700 to \$4,100 more in student loan payments each year.

authors have endorsed and supported plans to cut Social Security by raising the retirement age for roughly 8,482,923 Ohioans. They propose raising the Social Security retirement age from 67 to 69, which would cut benefits by \$4,100 to \$8,900 after just one year, depending on when one claims Social Security. Project 2025 would repeal the health reforms that Democrats secured through the Inflation Reduction Act to lower the cost of prescription drugs for Medicare beneficiaries. Eliminating these reforms would raise the cost of prescription drugs for up to 154,000 people in Ohio's 13th Congressional District. Ending Medicare drug price negotiations, would also directly increase drug prices for 36,000 Medicare enrollees in Ohio's 13th Congressional District who take any of the 10 drugs for which Medicare negotiated lower prices.



The plan will cut food assistance for up to 99.000 99.000 individuals in Ohio's 13th Congressional District who rely on the Supplemental Nutrition Assistance Program (SNAP) to put food on their families' tables. Project 2025 rolls back benefits for everyone receiving SNAP and makes it harder to enroll. This will especially harm children, families, older Americans, people with disabilities, and veterans.

Project 2025 would require states to 7,988,132 allow federal government access to voter registration databases. This information could be used to interfere with maintaining accurate voter lists, leading to errors or inconsistencies, and casting doubt on election results. Aggressive voter purges might disenfranchise eligible voters, particularly from marginalized

communities, affecting turnout and representation for the 7,988,132 registered voters in Ohio.



Project 2025 proposes a \$17 billion cut in grant funding to

schools across the country, which would lead to reduced resources, programing, and staffing for public schools.

Project 2025 1,620,000 eliminates certain

emergency contraception medications from free preventive care requirements, meaning 1,620,000 women in Ohio would lose guaranteed access to free emergency contraception. Project 2025 would also ban medication abortion and criminalize mailing it nationwide, even in states where abortion is legal. It also calls for a nationwide surveillance system to monitor all pregnancies, requires reports on any women travelling out-of-state to seek abortion care, and takes federal legal action against local officials who refuse to bring cases against women and doctors who violate a state abortion ban.

Project 2025 is projected to raise Ohio residents' annual energy costs by an estimated \$150 per household by 2030. Despite plans for expanded oil and natural gas development, these costs may not be offset, potentially leading to job losses in the energy sector.
